# N Williams Avenue Sewer Extension Project Construction Begins Week of March 9


Environmental Services is extending the public sewer on N Williams Avenue from N Fargo Street to provide public sewer access to a nonconforming sewer property on N Williams Avenue. This project will be conducted in phases over the next two months. There may be periods of inactivity between phases.

### **Project Description**

This project will construct 109 feet of combined sewer pipe and a sewer branch to provide public sewer access to a nonconforming sewer property on N Williams Avenue just north of N Fargo Street.

The project will include open trench construction along the east side of N Williams Avenue from N Fargo Street to N Cook Street to build the new public sewer line. Crews will then use a trenchless directional drill to install the new sewer branch to the property frontage.

This project is separate from the large-scale sewer repair projects being designed in the Piedmont, Humboldt and Woodlawn-King neighborhoods.



# Schedule

Crews are anticipated to begin work the week of March 9. Crews will work Monday through Friday from 7:00 a.m. to 3:00 p.m. on N Williams Avenue. Work is expected to last up to two months.

#### **Construction and Traffic Control**

On-street parking will be removed between N Fargo and N Cook streets to create a safe work zone and accommodate traffic flow. During active construction, N Williams Avenue will be reduced to one travel lane shared by bikes and cars between N Fargo and N Cook. Traffic will be maintained on N Williams Avenue at all times, but delays should be expected.

#### **What to Expect During Construction**

- Construction creates noise, vibration and dust and disrupts normal neighborhood activity.
- You should expect traffic delays in and near the work area. Please observe traffic control signs and follow the directions of flaggers.
- Local access to all properties will be maintained, but construction activities may impact normal use of your driveway or entrance to your business.
- On-street parking will be restricted within work zones to create a safe work environment and accommodate equipment and materials.
- Some equipment and materials will be stored on your street or nearby streets overnight.
- A variety of factors, including conditions underground, weather, subcontractor schedules, and availability of materials may cause periods of inactivity.
- A city inspector will be on-site during work hours and may be able to assist you with an immediate need during construction.
- Your sewer service and other utilities should not be interrupted during construction.
